

## **Right direction, review and publication of scientific articles in international scientific and practical legal magazine "International Legal Courier"**

1. Accepted for publication materials that meet the academic profile periodicals, ie Only material legal subjects. They should be current, new and have the scientific and practical significance, as well as theoretical and practical value to representatives of the legal community.
2. Articles submitted in electronic form (via e-mail Address [inter.legal.info@gmail.com](mailto:inter.legal.info@gmail.com), [a.danelian@inter-legal.ru](mailto:a.danelian@inter-legal.ru)) or in writing to the address version of the application of the electronic version of the work on a CD.
3. The amount of publications - 0.7 AL (28 000 characters with spaces). If necessary, Editorial Board reserves the right to reduce the material and return it to the author reduction. The increase in the volume of work can be agreed with the editors.
4. On the first page (above the title of the article) in the upper left corner of the surname and initials of the author. Title of the article is printed after the surname, name and patronymic of the author. Pages not numbered. The main text, footnotes, text annotations and keywords are aligned the width of the page. After the author's name and the title of the article must be single-spaced place the text annotation articles in Russian and keywords. Then, single-spaced in the upper left corner should indicate the name and initials of the author and title of work English further - abstract and keywords in English. The article also It can be presented in English, with a translation of the name in Russian language, as well as abstract and keywords in Russian.
5. The quotation marks in the text and in the footnotes appear in the same format as follows: "." All Abbreviations except notoriously well-known, must be decrypted at the first use in the text. Charts, tables, and figures should be Decorated in a text editor Word.
6. References and notes placed page by page, with continuous numbering and shaped according to GOST R 7.0.5-2008. When making footnotes to indicate the name and the initials of the author of the work, its title, year of publication, page number, and other information. All bibliographic elements from foreign sources should be indicated in the original language of the possibility of avoiding abbreviations. When using electronic resources on the Internet should indicate the title of the cover page of the resource (), the full address of the location and resource (in parentheses) the date of the last visit to the web page.
7. After the article must be brought bibliographic list, those. a list of works cited by the author in the submitted material for publication. The list It does not include Internet sources, regulations, judicial and investigative materials practice.
8. At the end of the article should help bring about the author with the name, first name and patronymic, position and place of work (study), degree and (or) the title, and complete mailing address of the place of work. These data are published in the journal. The certificate separate from the above Information should also specify the postal code, address, contact telephone number, e-mail. These information not published in the journal and are required to communicate with the author of the editorial staff articles.
9. Presenting the text of the work for publication in the journal, the author guarantee the accuracy of all information about themselves, avoiding plagiarism and other forms of unauthorized borrowing in the manuscript product, proper preparation of all borrowing of text, tables, charts and illustrations. If an

article (material) is sent simultaneously to another publication or has previously published, the author must report it to the editor in the presentation of the material.

10. It is strongly recommended to check carefully before sending in the general journal spelling materials spelling of relevant legal terms and text design work and references. Editorial urged authors to check line submission of this Regulation, as well as electronic files-on viruses.

11. The fee for the publication is not paid (unless the article was published, commissioned by the editorial board and in accordance with the contract). Auto RU the opportunity to receive a free copy of the electronic version of the magazine, and a printed version of the magazine on condition of reimbursement for his shipment on said the author of the mailing address.

12. The authors of the editorial board passed the exclusive right to use the work in the following ways: play article (right of reproduction); Spread copies of the article by any means (right of distribution); translation of the article (on the right transfer). Submission of material released to the editorial office is conclusive action aimed at the emergence of the relevant rights and obligations. Consent author on the publication of the material to the conditions, and for placing it in electronic version of the magazine is supposed to. At the direction of the article to the editorial board has the right to author pre-negotiate exclusive (special) conditions of use provided they work. The author has the right to refuse publication available to them materials no later than the date of signing the numbers to press.

13. In case of violation of requirements to the design requirements of the material can be returned to the author for revision. Manuscripts sent to the authors for revision, subject return to the editor in the recommended time. On Amending the author must inform in the attached letter to the manuscript. In the case of non-compliance with the requirements imposed by the author Editorial Board has the right to refuse to publish material submitted by the author a reasoned explanation of the reasons for such denial.

14. The manuscript of scientific articles, Received Journal in print or in electronic form is considered the head of the department of scientific publications in the magazine compliance with the profile of the magazine, the requirements for registration and logs Accounting Received manuscripts.

15. The publication shall review all incoming materials to the editor, corresponding to its category, with a view to peer review. All reviewers are recognized experts on the subject and have reviewed the materials for the last 3 years the publication of peer-reviewed articles on the subject. Reviews are stored in Publishers and editorial office for 5 years.

16. The received manuscript to two weeks and is considered by the Editorial Board Editorial Board of the Journal and its approval is sent for review. Choice reviewer exercises the chief editor or, under its instructions, members of the editorial board. Reviewers may make members of the Editorial Board, the members of the editorial board of the Journal, guest edited by scholars with academic specialization, closest to the topic articles, as well as other reviewers – highly practitioners. 17. The manuscript is submitted to the referee in hard copy and (or) in electronic form. Reviewer notified that sent him to review the manuscript is subject to copyright and are reportedly not subject to disclosure to its Pub. Reviewers are not allowed to make copies of the manuscript and send it to third parties.

18. Revision of publication to the authors of submissions or copies of reviews reasoned refusal, and undertakes to send a copy to the Ministry of reviews Education and Science of the Russian Federation for admission to the editor of Publishing prompted.

19. The term of preparing the review established in coordination with the reviewer, but can not more than two weeks from the date of receipt of the manuscript to the reviewers. The reviewer is entitled to refuse to review within one week of receipt of the manuscript to him and notify the editorial board.

20. The review should include an analysis of the material qualified article, objective and reasoned assessment of its material and reasoned recommendations for improvement the quality of the work presented. The reviewer evaluates the main strengths and weaknesses manuscript, guided by the following criteria: relevance of content Articles Profile magazine, the relevance of the chosen topic, the scientific and methodological level, the use of necessary methods of research, innovation and originality of the main propositions and conclusions, practical utility. In the analysis of the submissions, retsenzentsomudelyaetsya attention to the following issues:

- A general analysis of the scientific level, terminology, structure of articles, the relevance of the topic;
- Assessment of readiness article for publication in respect of language and style, matching the requirements for the materials section;
- Scientific exposition used by the author matching methods, techniques, advice and research sovremennymdostizheniyam science and practice;
- Place the book under review, among other works on this topic: What's new in it or something it differs from them, it does not duplicate any content of the manuscript of the work of other authors or earlier printed works of the author);
- The author admitted inaccuracies, errors, violation of the rules of citation. If necessary, recommendations on the issues reflected in the text of the review.

21. As a result of the review may be made the following decisions:

- Recommend the adoption of the manuscript for publication;
- Recommend the adoption of the manuscript for publication with the introduction of technological changes;
- Recommend to take the manuscript to be published after the removal of the author (s) comments reviewer, and then focus on the re-review the same reviewer (at the recommendation of reducing or refining the manuscript to review specific indicating thereby the manuscript should be reduced, that it should be corrected, to help the author (s) for further work on the manuscript). If author (s) has not eliminated the comments from reviewer, the Editorial Board has the right to to refuse to publish the manuscript with the direction of the author (s) a reasoned refusal);
- To recommend to refuse to publish the manuscript because of its non-compliance, requirements for scientific level (in this case, the editorial board has the right to send the manuscript for review to another reviewer or send the author (authors) a reasoned refusal in the publication of the manuscript, with a copy of the negative review).

22. In case of disagreement with the opinion of the reviewer, author (s) shall be entitled to the manuscript contact the editorial office with the request to send the manuscript to another reviewer, with bringing the outstanding relevant arguments. In this case the editorial board Magazine sends the manuscript for review or re-offered to the author (authors) a reasoned refusal. The decision to publish the manuscript accepted after peer review editor in chief Journal or - the editorial board. The decision to publish the manuscript brought to the attention of the author (s). In the presence of the negative reviews of the manuscript from two different reviewers or a negative review of the revised version of the manuscript, the author (author) is sent to a reasoned refusal to publish the manuscript with a copy Negative reviews (without a signature and the name, position, place of work reviewer.)

23. The maximum period of review (including repeat and additional peer review) is two months from the receipt of the manuscript to the editor.

24. Publication of the material presented in accordance with the plan editorial work, taking into account the need for the formation of various headings in each room magazine and funding issue of the magazine.
